At the CSBA conference, teachers are asking questions, but the state does not have any answers yet. It's the blind leading blind. She commended staff for being part of solution not the problem.

Mr. Guzman said that there will be a lot of learning but we are in this together. Dr. Boyd and Board are the models using the technology with their iPads. We are not waiting for state. With the LCAP & LCFF the state is supposed to be working on delivering a template, but he said the District is not going to wait for that and are developing one based on 8 priorities.
