- 7. <u>2012/2013 Audit Report</u> Ms. Samantha Moore, VTD & Co., LLP

Ms. Moore reported on the 2012/2013 Audit highlights for Soledad Unified School District as follows:

- Page 5 District's annual financial report, presenting the discussion and analysis of the District's financial performance during the fiscal year that ended June 30,2013.
- Page 7 Management's Discussion and Analysis. Reporting the District's fiduciary responsibilities, financial highlights and the district' as a whole
- Page 14-15 Enrollment projects which are based on ADA & growth trends. These pages also include the Statement of activities of revenues and expenditures
- Pages 16-18 Governmental Funds Balance Sheet. Including the Building fund which is major this year; once the district completes complete the construction of the middle school, it could become a non-

major fund. Also the Cafeteria fund and the influx of federal funds, it could become a major fund and it could change from year to year.

- Page 51 General Fund Budgetary Comparison Schedule

- District has a 20% reserve. ADA has increased by 132 over past 2 years. Most districts are in declining enrollment.
- Page 73 Summary of Auditors Reports
- Pages 74 76 Summary of Auditor's Results. There were no findings to reporting level. Control weaknesses were not of magnitude that they need to be in reported.

President Barrera said he was concerned about the report on the Associated Student Body Funds. The same issue pops up every year. He said that staff needs workshops, not only officers but with changing staff, the teachers, club advisors need to be included she said it was very rare not to have any ASB findings. Ms. Moore said it was an issue on most districts; but it was beneficial that sites have support of the district office. Good to see that we do have support of the district. Mr. Barrera was concerned and said that the district needed to get involved as we don't want to see what happened north of our city or be on the news.

President Barrera also asked about the double payments made on invoices and asked if it was something within the system. Ms. Moore said it was with the county office and suggested that they put something in their system to flag that the invoice was already paid, to prevent that from happening.

- B. <u>Educational Services</u>
 - Curriculum & Common Core Updates Mr. Guzman Mr. Guzman, Associate Superintendent of Educational Services, reported on the following:
 - Administration was recommending the approval of Draft A Calendar for the 2014/2015 school year. It was on the agenda for approval this evening. School will begin 8/18/14 – 6/11/15

- Mr. Guzman thanked the Board for attending the Board Retreat March 8th where they hear an update on Common Core and SBCA (testing) to be held April 7-May 16 using technology.
- CAHSEE is coming up next week.
- The District was recommending the Board's approval of an MOU with Hartnell for Career Pathways. \$15 million are at stake. The Pathway selected was Agriculture. There was a last minute revision to the MOU and Mr. Guzman distributed it for their approval.
- Teachers attended a Math Fair to look at instructional materials and ready for purchase. The committee will select materials and do a pilot run, then it will be recommended for board approval
- The Board had approved Full day Kindergarten to August 2014. However, two school sites have expressed an interest in running a pilot full day program at Rose Ferrero. They want to find the "kinks" and work them out; then share with the rest of the staff so that we are ready to go in the fall.

Trustee Massa asked if we have control over the dates when we test our students or they control it. Mr. Guzman said the State gives us a testing window.

President Barrera said there was going to be a PBIS workshop in Salinas and one of the renowned speakers was coming. He encouraged district participation
