- Trustee Berlanga congratulated the students of the month and parents.
   She said that parents should continue to encourage and support them.
   Trustee Berlanga said that we had great teachers and a great district. To Mr. Kutter, she thanked him for giving 33 years to the district.
- Trustee Ledesma congratulated Frank Ledesma School for two awards they received. She said she was proud to see Soledad printed along in the same line with Carmel and Pacific Grove. She also commended, the students and teachers for making a big difference
- Trustee Massa said that she read in the school bulletin this week the comments made by Soledad High School students regarding the 8 common core priorities. She was also happy to read in Ms. Estrella's report that one of our students, Laura Gasca won gold in state competition and she will be representing Soledad at National level. She congratulated Laura for this great accomplishment. Trustee Massa also encouraged everyone to go to the Fair and support the FFA students.

#### B. Educational Services

- 1. Curriculum & Common Core Update— Mr. Guzman
  - ✓ LCAP Plan Mr. Guzman reported on the 8 priorities of LCAP. A team met with county today to get feedback on the plan and we are closer to completing it. There was a discussion with students and our community to get input to craft this plan. Mr. Guzman said that there will be report given to the Board at their next regular meeting of June 11<sup>th</sup> when there will be public hearing on the LCAP Budget.
  - ✓ Summer School Planning Summer School will be held at Gabilan. This year it students will be able exposed to the arts and music. Principals will meet to plan the 3 week program. Summer School will also be held at Soledad High School.
  - ✓ There will be a recommendation of summer expansion work by teachers to create lessons on common core. The lesson will then be shared out with teachers.
  - ✓ Working with John Matich from LAEP and Dr. Ilene Straus on LCAP and steps to move forward with professional development and Common Core.
  - ✓ Denise Estrella, Director of Special Projects, shared the new format for the Single School Plans for Student Achievement. This part of the work is to align the School Plan for Student Achievement to the LCAP. These plans will then be brought to the Board for approval. Ms. Estrella said this was not anything new. This a document that describes how we spend categorical money. This is an updated plan so that it is more transparent on data, summary and goal setting. Overall this is a better document and is comprehensive. One of the strengths of the new format is that it has all the components that the state requires. She hopes to bring these to the Board for their approval in June.
  - ✓ Staffing positions will be on EdJoin
  - ✓ Dr. Boyd said that with LCAP, one of the goals is to align budgets and use it to guide instruction at the sites. We will look at the data, look at site, and use the funds to support the programs. Title I funds will be sent back to the schools sites, as they are the only ones that know how to best support their students. Anything we require kids to do, their budget should support that. If they want to send students to camp; the site administrator will need to allocate funds for that. If they are going to a play, the same will apply. Any required curriculum or needs of schools, money should be allocated those items. However she does the funds should not be used to pay for people; rather pay for services directed to students. The district will come out with guidelines for the sites to go by. Dr. Boyd and Mr. Guzman thanked principals, staff and students for their work with LCAP.

Discussion on item #12

- ✓ Mr. Guzman, Associate Superintendent gave a summary of why the recommendation is being made to close Chalone High School name and integrate those students into other programs at Pinnacles or Soledad High Schools. He said that CEC has the following programs: Pinnacles, an Alternative High School; Adult Education and Chalone High School which is an Independent Study Program. These programs allow some of our students to work in an alternative setting. However, there is a 10% cap on those students that can attend these programs and if we look at number, there is a disproportionate number of students attending Chalone High, which is a big concern. The program to serve these students in an alternative setting will continue. The plan is to collapse the state CDS number; but it does not mean we won't address their needs. We need to put academic rigor in place and new ways of addressing needs of student. All students need core subject access. Under these two schools (Pinnacles/Chalone), we have to have two WASCS, which means a tremendous amount of work. We need to create new pathways for them to be served. Again the proposal is to close the State ID number and serve student through Pinnacles and Soledad High Schools. Currently students come to Chalone and meet once a week with their teacher on a one to one basis. We have 19 special education students who need extra help and they are not getting it coming in once a week. Also the WASC report indicates these concerns. We need to evaluate and see where the gaps are and customize the program for them. With the implementation of E 20/20 next year, it is more critical that we support our homeless youth.
- ✓ Mr. Guzman said that this will also meet with the intent of LCAP and the 8 priorities. This is a better way to service student. They can take online classes and accelerate depending on them. The Programs will be customized for them.
- ✓ Dr. Boyd said that we need to make sure that they compete in today's job market. There is a need to revamp even the alternative high school. We have to prepare our students to be able to compete with other students worldwide. In these programs, each child is unique much like an IEP; we have to have individual graduation plans. That is also why the Board will also be seeing some shifting of positions to address the needs of these students.
- ✓ Trustee Ledesma asked about why the graduation numbers are down. Dr. Boyd said graduation is 79% because we move students to Chalone. In order to do it equitably because they don't fit in, we need to address the learning modality. This is a huge concern when you have a large population of SPED students over represented in one school. It is disproportionate. The students with the highest needs are being sent to a school where they are expected to do work independently, once a week, and rest of the week; we are expecting them to learn independently. That is not how Special Education works. Mr. Guzman said that these students need more access to core subjects. Dr. Boyd agreed and said we don't have that there currently and we also need to put in technology at that site.

- ✓ President Barrera asked what happens to students; do they transfer. Mr. Guzman said they will look at each student, case by case, individually, and they will either be going to Pinnacles or Soledad High School. There will be staffing shifts as we need to place them in areas within their credentials; either at the high school or middle school.
- ✓ Dr. Boyd said there are currently: 10 student who are 19 years old and are in Adult Education; 19 student are part of Chalone SpEd and would like to place a SpEd teacher at Pinnacles High; 11 at Independent Study who will go to the high school as they need core curriculum and 40 students on credit recovery which would have a modified schedule at Pinnacles High. Computers would then be placed in the portable where Chalone is. She said she needed to make sure the students also have technology on that campus.
- ✓ Pinnacles High School is based on students' schedules and the alternative schedule is based on what they need.

President Barrera opened comments to the audience and said he would be enforcing the 3 minute.

- ✓ Mona Montoya, retired employee who used to work at Chalone, Pinnacles and Adult Schools. She said she worked with students and on 1:1 and did attendance. She said that in the 1980's Chalone serviced adults and people from other communities. It was unique because they got one on one with the teacher. She invited all those who have never been to Chalone to go visit as it's a lot of work. Invited them to go and visit; it's a lot of work. The program is individualized, students had to go home and come back with the work completed. Her daughter graduated from there and a board member's wife graduated from there. She asked, why would they want to close the school? Some kids won't make it at regular high school. They will be. She said that they need to think of students and not them. That's why you are education you need to be compassionate. Some students would go to school with their babies and were proud of themselves that there were able to do that.
- ✓ <u>Sheila Bengston</u> said she taught for 37 years and retired last year. She spoke about how the school started with Gonzales Union in the 1980s with two teachers and to serve drop outs and teen moms. Then Superintendent, Randy Olsen, started the program and grew it. Later in 1986 it moved to medical building on East St. Students came for variety of reasons and it served adult and high school students. In 1989 there were five teachers with areas of expertise and a full office staff. Fred Green was principal and one of the best independent study school in the county. It grew and they had to teach independent study in a patient room at Eden Valley. Because of the special needs of students, they created at high school in 1999 in

Soledad to maximize students' services for special students and maximize funding. That is why they became separate school. The district gets money and count the students when writing grants; yet they don't get any of that money. She asked the Board to vote this recommendation down.

- ✓ <u>Dr. Nolan</u>, also addressed the Board and said he was teacher at Soledad High School for 5 years and for Soledad USD for 11 years total. He came to speak about Chalone's closure. He said he learned about it on Monday with no prior discussion. Why should the board reconsider action: He has been five years at Chalone and has seen kids come and go and they all have different issues such as teen pregnancy and gangs. They go there because they don't have distractions in Independent Study Program. It is the last stop for some of these students. To close the school would mean closing the future of many of these students. He said that what we have now, is what is working for these students. Reconsider this action.
- ✓ Mary Oxedine Teacher at Chalone High School, addressed the Board and said that she had 67 students scheduled each week at Chalone. The SpEd students are not included in her schedule and she is not a SpEd teacher. She said that they have to tell 8 students 19 years old and up, where they will go in the fall? Or will they have to go to adult Education? She said that some are close to earning a diploma. Twelve (12) teen mothers/fathers have to be told why they no longer have a school. They have to break news to students with health and emotional issues that need individual attention that this will come to an end. Seven (7) students that work have to be told that they have to choose between working or earning diploma. Probation students, what do we tell them? That they have to be lumped at Pinnacles High School with students that help them get into trouble. ADA for SpEd is not included in part of Chalone which lowers attendance at Chalone. This is also true for CAHSEE students. Tomorrow at 8 a.m. they will have to have answers for students. She asked the Board to reconsider this action.
- ✓ Student Robledo said she was disappointed that they want to take Chalone away. She said this was her first year going to Chalone where she got A's and B's. Right now Dr. Nolan and Mrs. Bengston have helped her a lot. She has a lot of emotional problems and said her education will be ruined and jobs taken if the Board takes this action. She hoped that everyone speaking will make them change their mind.
- ✓ Virginia Alvarado as a teacher they have done so much. 7<sup>th</sup>/8<sup>th</sup> graders going to Chalone figure out where we will house them. Spoke about a modified schedule. 8 years at high school at Main street; Chalone and now at PHS. We are getting raises and talking about throwing them away. Modified schedule does not work. Hybrid Program were very diverse and progressed and all little bits and pieces not accounted for. Administrators speak nice but they don't know how it affects them.

Academies, rigor – next year – with all new staff –really too much to ask –asked to table it and figure it out somewhere else.

- ✓ Robert Lauck, a teacher at Pinnacles High School. He said he want to associate himself with remarks from colleagues. He also thinks about a tier intervention at CEC and absorbing Chalone students at the Pinnacles Highs is not feasible or to the regular high school. These students go to Chalone because they can't get to school on a regular basis. It won't work.
- ✓ Angel Rivera addressed the Board and said he was a former VP and is a counselor at CEC and was baffled to hear what is happening. This is a school that received a 6 year WASC Accreditation. That is not a mediocre school and it is a high performing, rigorous school. Students are passing CAHSEE. This is not a credit factory as you think. Even today 99% showed up to take CAHSEE. He said he knows this because the does the curriculum for CST and CASHEE. He said this were non-traditional students that and is the reason why we have alternative education: not all students can make it in traditional education. The program is working. Students show up at school at 5:30 − 9 p.m. to receive an education. He was let go today and the district will hear from him on that. He said that nothing has happened. No planning for a situation such as this. As an administrator he is baffled. You organize and share, talk about it. This should not happen.
- ✓ Mr. Bourke, Teacher at Soledad High said he had the following points: How did those 22 SpEd students end up at Chalone? What will happen when the 1:1 interaction is taken and student are moved into a larger group, what will it do to their IEPs? If you put them in at Pinnacles High what about the over representation and access to core content classroom and online technology? He heard about the kids and that the LCAP money is for students, you are cutting the program that provides needs of students. Also what about change in working conditions?
- ✓ President Barrera asked if Dr. Boyd had any comments. Dr. Boyd said that programs have changed and she understand the historical and traditions; however, we have to make sure we accommodate students with the appropriate skills. Currently, we are not preparing high school kids, let alone Chalone students. Students are at the forefront of this. We are adding \$1.1 million of additional teachers directly to kids; \$500,000 towards intervention specialists to meet those needs. Money is going towards that because accountability is gone toward this. We have a 79% graduation rate which is not acceptable. Out of 100 students, we lose 21 to Chalone which means we have not figured out what the problem is. We are just placing students somewhere else and the chances of them dropping out are greater.
- ✓ Mr. Guzman said that big priority is to zero dollars towards student services. However it will look different. It is historical issue, we are talking about the program

but at the same time, we have to prepare our SpEd students that need intervention and currently, we are doing a disservice to them.

- ✓ Trustee Massa said that one thing jump out to her was the concern on baby strollers on the high school campus, has that been thought it through.
- ✓ Dr. Boyd said we would put in supports; the family liaison would be placed at that site to support the mothers while they go to school, modify the program. It is not traditional but we are not in the 1980's and CDE's has guidelines that we have to meet. We can give them a laptop can take classes online with tutorial to help kids and they can get their skills at same time. We need to get into digital age to be competitive, it is changing.
- ✓ Trustee Fernandez recommended tabling the item and taking a second look at this. He said that having had experience with at-risk youth, he understand that through their own actions, they put themselves in that position; however he was concerned with what will happen to those students and how will it affect the community.
- ✓ Dr. Boyd said that those students are out there in the community and come in to the program once a week.
- ✓ Trustee Fernandez said he understood that and again said that they put themselves there. But it might be that day at school that keeps them from doing anything because they know if they do, they can get in trouble at school.
